

# **REPORT BY THE OUTGOING CHAIRPERSON-**

### **1. Highlights of the achievements by Team 2012-2017**

- All tax related issues were sorted out on a priority basis. The landmark achievements have been the acquisition of Registered Charity status for our society (U/S 12A, DEL-RR22975-05062013/1847) on 05-06-2013, followed by 13u/80G status (DEL-RE 25104-03122013/3892) on dated 03-12-2013.
- Account maintenance streamlined. TAN, Service Tax and GST compliance-all in line now under regular supervision of our CA-Mr. Kohli and assistants.
- All previous dues settled.
- On line registration for all courses, CMEs and conferences started and continuing well. A high quality website created and regularly updated.
- All RCOG courses continued with full booking and excellent feedbacks.
- A highly successful 28<sup>th</sup> All India AICC RCOG Conference was organized on 29, 30, 31 August & 1 September 2013 with more than 500 participants.
- Annual Conference each year conducted with high standards and excellent attendance and feedbacks. Several other CMEs, charitable activities and public awareness events organized by North Zone members were actively supported.
- Live Videoconferencing of 3 prestigious and popular RCOG courses organized in year 2016.
- Actively contributed towards success of RCOG World Congress 2014 in Hyderabad and got awarded by the College with compliments and share of the profits.
- Sims Black Fellowship CME honoured by the participation of Professor Sir. S. Arulkumaran was organized on 9<sup>th</sup> & 10<sup>th</sup> September 2016 at Indraprastha Apollo Hospital and Maulana Azad Medical College with huge success and excellent feedbacks.
- Yearly MRCOG Examinations- both Part I and II carried out on 1<sup>st</sup> Monday and Tuesday of September each year at Indraprastha Apollo Hospitals.
- Pilot MRCOG OSCE Exam and pre-exam OSCE course were conducted successfully in 2015.
- As part of our social responsibility and obligation as a charitable society, Rs 6 Lacs have been donated for the higher education of underprivileged girls studying at "Amitasha" school run by Amity Humanity Foundation (The figure of Rs. 6 Lacs decided as contribution of Rs. 10,000/- per month over 5 years period).

- CR Park North Zone RCOG Academic Centre Academic Centre maintained in the best possible conditions with regular payment of its Property Tax, Insurance cover and Fire-safety measures till date.
